

Information for Membership Policy Page

SECTION I: MEMBERSHIP ELIGIBILITY

Listed below are those that are eligible to purchase memberships to the Fritz B. Burns Recreation and the fees and effective dates associated with each.

I. LMU UNDERGRADUATES – FULL-TIME (12 Units or more)

All full time undergraduate students are automatically members of the Burns Recreation Center.

II. LMU PART-TIME UNDERGRADUATES

LMU part-time undergraduate are eligible to utilize the Burns Recreation Center. Membership fees are as follows:

Individual Membership

Semester Summer/Fall/Spring \$100.00

Academic Year (08/31/09-05/09/10) \$200.00

Family Membership

Semester Summer/Fall/Spring \$200.00

Academic Year (08/31/09-05/09/10) \$400.00

An academic membership is valid for the academic year (08/31/09-05/09/10). The semester dates are as follows: Fall (08/31/09-01/18/09), Spring (1/19/10-5/09/10), Summer (5/10/10-8/29/10). Verification of current enrollment per semester (Fall and Spring) is required. Students on a leave of absence are not eligible to purchase a membership.

All students (except Loyola Law) **MUST** charge the membership fee to their student account.

Loyola Law Students may pay with credit card (Visa or Mastercard).

III. LMU GRADUATES AND LOYOLA LAW STUDENTS

LMU graduate, and Loyola Law students are all eligible to utilize the Burns Recreation Center.

Membership fees are as follows:

Individual Membership

Semester Summer/Fall Spring \$65.00

Academic Year (08/31/09-05/09/10) \$130.00

Family Membership

Semester Summer/Fall/Spring \$130.00

Academic Year (08/31/09-05/09/10) \$260.00

An academic membership is valid for the academic year (08/31/09-05/09/10). The semester dates are as follows: Fall (8/31/09-1/18/10), Spring (1/19/10-5/09/10), Summer (5/10/10-8/29/10). Verification of current enrollment per semester (Fall and Spring) is required. Students on a leave of absence are not eligible to purchase a membership.

All students (except Loyola Law) **MUST** charge the membership fee to their student account.

Loyola Law Students may pay with credit card (Visa or Mastercard).

III. LMU FULL-TIME STAFF/FACULTY & EMERITUS STAFF/FACULTY

All full time staff and faculty are eligible for membership to the Burns Recreation Center.

Membership fees are as follows:

Individual Membership

Monthly \$11/month

Family Membership

Monthly \$22/month

Payroll Deduction Membership*

Faculty / Staff Individual (\$5/check) Faculty / Staff Family (\$10/check)

* Full-time faculty and staff are also eligible to purchase a Payroll Deduction membership, which is continuous until termination of employment or until a written notice of cancellation is submitted to the Department of Campus Recreation.

IV. LMU PART-TIME FACULTY AND STAFF

All part time staff and faculty may purchase an individual membership, but are **NOT ELIGIBLE FOR FAMILY MEMBERSHIPS**.

Membership fees may not be deducted via Payroll Deduction. Accepted forms of payment are credit card (Visa or Mastercard).

V. CONTRACT VENDORS

All LMU contracted employees (Collegiate Press, Follett Bookstore, Sodexho Alliance, GHG Security) are eligible for memberships to the Burns Recreation Center. The membership fees are as follows:

Individual Membership

Monthly \$20/month

Family Membership

Monthly \$30/month

VI. LMU AND LOYOLA LAW SCHOOL ALUMNI

All LMU and Loyola Law School Alumni are eligible for memberships to the Burns Recreation Center. Verification of alumni status is required prior to the purchase and activation of membership. The fees are as follows:

Monthly \$34/month

Family Membership

Monthly \$50/month

****All Memberships are continuous until written notice of cancellation is received by membership services. ****

VII. LMU RELIGIOUS COMMUNITY

IX. FAMILY MEMBERSHIPS

Students, Full-time Faculty and Staff, Contract Vendors, and Alumni are all eligible to purchase family memberships. Family memberships include a spouse and all children under the age of 18. All family members (spouse and children) must obtain an LMU ONECARD through the Member Services office. Children under 16 years of age must be accompanied and supervised by a parent or guardian at all times, and are not allowed in the Fitness Center or Activity Studios. Children 16 or 17 years of age who are living at home will receive a ONECARD for access to the Burns Recreation Center. All spouses must provide a valid driver's license at the time of registration for identification purposes and proof of residency.
